He was moved to another section. But he went on nagging the girl then and there. He wanted to shift over to the previous section. But it was not yielded by the HOD.







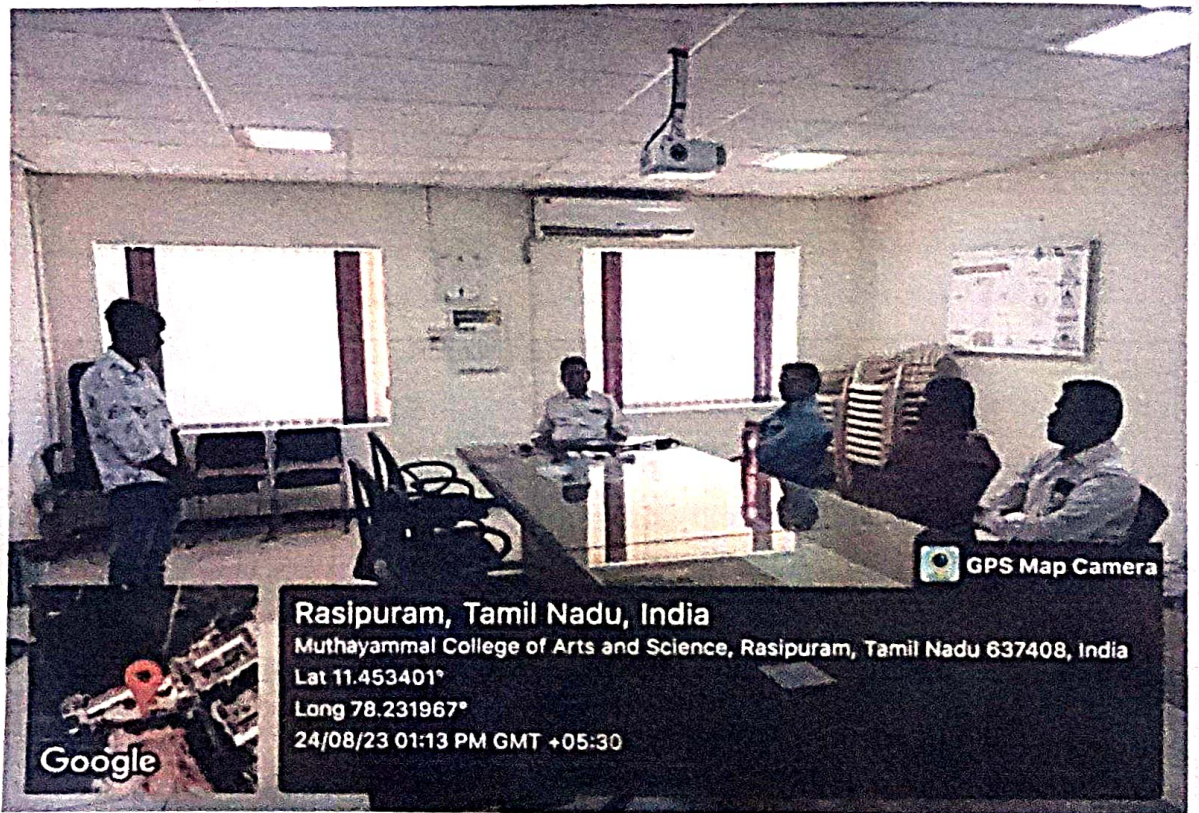
He went home and got drunken. Then he threatened the HOD over mobile phone that he would attack him if he would come out of the college campus or while travelling to his native place.







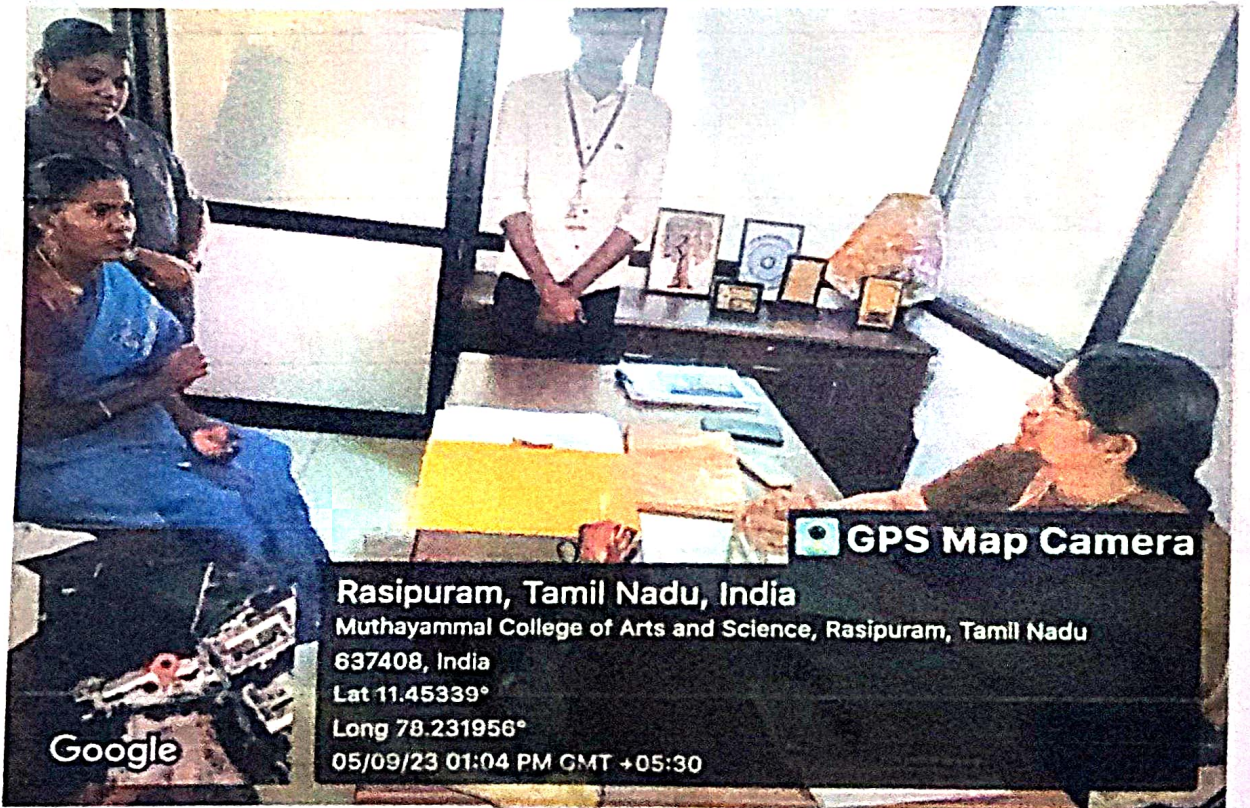
It is rather undigestable because he had already been suspended earlier on a charge that he physically assaulted a fellow student.

* Finding that the girl was not at home, the parents came to the college and met the Principal.






